Facility Policies & Procedures



1. ASSUMPTION OF RISK

- Each participant is responsible to determine whether he/she has the proper fitness level to participate in activity at the Kevin T. Keane Sports Park.
- Participation in activity at the Kevin T. Keane Sports Park is voluntary, whether that be a facility sponsored program or outside group program. By voluntarily using the Kevin T. Keane Sports Park, participants assume all risk for any harm or injury sustained.
- Consider the consequences of your actions and do not engage in behavior that may harm other patrons or damage equipment.
- Nardin Academy is not responsible for injuries sustained while participating in athletic or other sporting activities at the Kevin T. Keane Sports Park. All physical activities offered at the Kevin T. Keane Sports Park are on a voluntary participation basis and carry various degrees of risk or injury. Participants assume sole responsibility for any and all such risk or injury that may result due to voluntary participation. It is each individual's responsibility to be knowledgeable of his/her own physical condition when participating in any activity.

2. PATRON ACCESS

a. Waivers

- All patrons of the Kevin T. Keane Sports Park are subject to the agreement of the Individual and/or Group Waiver prior to accessing the facility.
- External Groups and Special Groups are required to provide a signed Kevin T. Keane Sports Park Individual and/or Group Waiver for each user.
- Users under the age of 18 must have a parent/guardian sign an Individual and/or Group Waiver before gaining access to the Kevin T. Keane Sports Park's facilities.

• **Facility Policies & Procedures** •

- Large external organizations requesting space at the Kevin T. Keane Sports Park may submit a certificate of insurance in lieu of a signed waiver. The certificate of insurance must meet Nardin Academy and/or the Kevin T. Keane Sports Park's general liability requirements and name the proper lessor as an additional insurer and certificate holder. More Information below.

CONDUCT POLICY

Athletes, spectators, and guests are expected to set a superior example of sportsmanship and respect of others on the premises. Abusive or offensive language will not be tolerated. Physical violence of any kind will result in immediate removal from the venue. Spectators are not allowed on the court or field of play. Individuals in violation of the conduct policy may be asked to leave.

DRINKING FOUNTAINS

Water drinking fountains are located both indoors and outdoors. Spitting in drinking fountains is not permitted.

FIELD RESERVATIONS

For field reservations at the Kevin T. Keane Sports Park, whether indoors or outdoors, reservations are based on availability, with priority towards 1)

HOURS OF OPERATION

As a year-round sports complex, we strive to maximize as many hours of the day as possible to allow members, guests, and groups to use the facility. Hours of operation are subject to change based on the season.

LOST AND FOUND

The Kevin T. Keane Sports Park is not responsible for lost, stolen, or damaged items. All guests are encouraged to leave valuables at home and/or lock personal items in their vehicle when attending events at the venue. Outside food and beverage is permissible at the Kevin T. Keane Sports Park, but is not allowed on any of our synthetic turf fields, including spectator and player bench areas, or squash courts, with the exception of water on the synthetic turf fields. Sale of outside food and beverages during an event must be approved by Kevin T. Keane Sports Park staff.

PET POLICY

Pets are not permitted at the Kevin T. Keane Sports Park. Service animals are allowed for persons with disabilities.

SOLICITATION

Only Kevin T. Keane Sports Park sponsors will be allowed to distribute or circulate commercial advertisements at the venue.

SQUASH COURT RESERVATIONS

With seven (7) international singles squash courts, court reservations for members, guests, and walk-ins can be made through ClubLocker.

TENT POLICY

• **Facility Policies & Procedures** •

Kevin T. Keane Sports Park guests are permitted to use “popup” tents in spectator areas. Tents must be safely secured. Absolutely no staking permitted on turf surfaces.

TOBACCO AND VAPING

The Kevin T. Keane Sports Park is strictly a non-smoking facility. No smoking or other use of tobacco products including pipes, cigars, cigarettes, or chewing tobacco is permitted in any part of the venue’s property. Vaping is not permitted.

WEATHER POLICY

INDOOR - As an indoor sports facility, we try to stay open in all weather conditions. Our facility does not tend to follow any Nardin Academy’s cancellation policies. Cancellations/closings will be communicated through email, as well as social media.

OUTSIDE - The Kevin T. Keane Sports Park follows the NYSPHAA Thunder & Lightning Procedures. In the event that thunder is heard or lightning is seen in the area, play will be suspended and all participants, spectators, anyone else on the property will be required to vacate the outdoor complex and seek shelter. Please adhere to the following rules and guidelines while using the outdoor fields:

- NO metal spikes.

- NO food.
- NO sunflower seeds or any seed food items on turf or in dugouts.
 - NO chewing gum.
 - NO pop, juice, coffee, or sports drinks.
 - NO glass containers.
 - NO alcohol on the premises at any time.
 - NO tobacco products of any kind.
- NO dogs, pets, or other animals on the premises.
 - NO golf, hockey, or javelin throwing.
 - NO bikes, rollerblades, or skateboards.
 - NO climbing goal posts or fences.
- NO painting, chalking, tape or other adhesive material without prior approval.
 - Please do not enter the field until your time session begins.
 - Please properly dispose of all garbage in trash cans.
- Adult supervision required at all times for anyone ages 12 and under.
Adult is herein defined as an individual who is at least 21 years of age.
- Group leaders/coaches are required to remain with the group at all times and are responsible for the group's conduct and compliance with all rules.

NARDIN ACADEMY ATHLETIC CENTER SISTERS (INDOOR) FIELD - RULES & REGULATIONS

**Please adhere to the following rules and guidelines while using the
indoor field:**

• ***Facility Policies & Procedures*** •

- No food, drink or coffee, chewing gum or sunflower seeds inside of Sisters Field. Water is permitted (NO COLORED SPORTS DRINKS such as GATORADE, POWERADE, ETC.).
 - No glass containers.
- Please dispose of all garbage in trash cans outside of Sisters Field.
 - No tables or chairs are permitted inside of Sisters Field.
- Please do not enter the field until your group's session begins.
 - No spitting on the turf field.
- No metal cleats or spikes may be worn on the turf field at any time (only formed rubber cleats are allowed).
 - No smoking, or consumption of chewing tobacco, or use of e-cigarettes are permitted inside of Sisters Field. No alcohol is permitted.
 - Any child under the age of 12, must be accompanied by a parent/coach in order to access Sisters Field.
 - Nardin Academy & Nardin Academy Athletic Center is not responsible for any lost or stolen items.
 - No swearing or offensive language in nature is allowed.
- All participants must fill out a "Release from Liability, Assumption of Risk & Indemnification" before entering Sisters Field.
 - Pets are NOT ALLOWED inside the turf area.

NARDIN ACADEMY ATHLETIC CENTER SQUASH COURTS - RULES & REGULATIONS

Please adhere to the following rules and guidelines while using the squash courts:

- Protective eyewear is mandatory on the squash courts. No exceptions!
- Clean, non-marking court shoes are required for court play.
 - Doors must be closed during all activities.

- Singles Squash Courts are intended for 1 player versus 1 player in match play, maximum of 3 players are allowed for practice/drills
 - No drink containers on the squash courts' wood areas
- Court reservations are limited to 60 minutes in duration based on availability.
 - Walk-ins are welcome
- All players, including Guests, must check-in before entering the Squash Center.
- Nardin Academy Squash team practice, clinics, camps, lessons and training will at times take precedence over all other activities.
- All players and spectators must adhere to the US Squash Code of Conduct, which is posted inside the Montante Family Squash Center.
- Failure to follow the Code may result in removal from the Montante Family Squash Center.
